24906	The True Value of Code Enforcement	Creating a synergy between economic development, zoning, community development and code enforcement allows for a comprehensive approach to community growth and improved quality of life. 24905	Dealing with Difficult People	Code enforcement officers and regulatory officials need to understand the personalities of the people they encounter on the field (customers) to deal with them appropriately and to resolve problems efficiently. 12961	Protecting Complainant Confidentiality	Confidentiality or nondisclosure is an arrangement by two or more parties in which some or all the parties agree that certain types of information that pass from one party to the other will remain confidential. 27159	Reclaiming your Relevancy	In the regulatory enforcement world, "relevance" can mean the state of being intricately connected or appropriate to the matter in hand. To be relevant is thus to be important, but the term implies more than that. 27612	SOPs, KPIs and Performance Metrics	One of the main reasons regulatory work flies under the radar is that the story is not properly being told. Many other departments in local government use performance metrics and KPI's to tell their story; in other words, they prove their worth to the decision makers. 12962	Vacancy, Blight and Local Governments	Most municipalities confronted with high rates of vacancy and blight are struggling. 13154	Legal Aspects of Code Administration	This session will provide an understanding of the legal foundation upon which code enforcement rests. Participants will learn many of the legal parameters in which they must work, including the history of ordinances and their enforcement, the hierarchy of laws and courts, the structure of local government, constitutional provisions relating to enforcement cases, "home rule," state laws, types of court proceedings and the courts in which they are brought.	6.0 0.60

This class will discuss the benefits of using blight remedies like abatements, demolitions and cease and desist orders to act on dilapidated housing.	3.0 0.30
40112	Understanding and Dealing with Mental Health issues in a Regulatory and Code Enforcement Setting	This course will explore ways to heighten the awareness of regulatory inspectors to reduce the risk of potential injury as it relates to dealing with the residents we serve; and to develop coping strategies for personal mental wellness.
